Barcelona, 10 May 2019

Barcelona (Catalan Occupied Territories)

Jordi Fornas, born in Barcelona (Catalan Occupied Territories), May 22, 1952 referred to as THE FOUNDER

AND

All Catalan patriots (13 people) who has signed this official document on page 3 are to be referred to as CO-FOUNDERS

INFORM

The UN Secretary- General, the Hight Comissioner of Human Rights Office, the OHCHR Independent Expert, the Office of Legal Affairs and the Special Committee of Decolonisation.

THAT

Taking into consideration the following international laws regarding the self-determination of peoples and nations:

Charter of Human Rights of June, 26th, 1945 – article 1, paragraph 2 and Article 55

“Resolution” n. 1514 (XV) – December, 14th, 1980 UN General Assembly;

“International Covenant on Civil and Political Rights” adopted in New York: December, 19th,1966

“Resolution” n. 2625 (XXV) of October, 24th, 1970 General Assembly O.N.U.

The Final Act of the Conference on Security and Cooperation in Europe: Helsinki, August, 1st, 1975




